Prime Minister and senior BJP leader Narendra Modi has said that the NDA government is making all efforts to make India a developed country. Addressing a rally in Jamui in Bihar, Modi said India has become the first country to successfully land a spacecraft on the moon's south pole. He said India has also become the fifth largest economy in the world. He said India also gives befitting reply to those who support and indulge in terror activities. Modi said those people can never do any good to the youth of Bihar, who asked youth to register their land for recruitment in railways. The BJP senior leader said during previous alliance governments only dilapidated trains used to run. But now like the whole country, people of Bihar are also traveling in the Vande Bharat train.

The Election Commission of India has directed print media houses, political parties, candidates or any other organization not to publish any advertisements related to political party or candidate on poll day and one day prior to poll day, unless pre-certified by MCMC Committee at the State or District level. The ECI said that instances of offending and misleading nature published in print media have been brought to the notice of the Commission in the past. In this regard, the restricted days for the state of Nagaland to go on the 1st phase poll on 19th April are 18th and 19th April. The ECI also informed applicants have to apply to MCMC not later than 2 days prior to the proposed date of publication of advertisement. The Commission further directed that in order to facilitate process of precertification of newspaper advertisements, MCMC at State/district level are

to be immediately activated in order to examine and pre-certify all such advertisements received from the political parties and candidates and others. It said that the decision by MCMC are made expeditiously.

The filing of nominations for the second phase of the Lok Sabha elections ended today. The Elections will be held in 88 Lok Sabha seats in 12 States and Union Territories along with the remaining part of the Outer Manipur Lok Sabha constituency in this phase. The voting for this phase will be held on the 26th of April. The scrutiny of nominations across all States and Union Territories will be done on the 5th of April except in Jammu and Kashmir. In Jammu and Kashmir, the scrutiny will be held on the 6th of April.

The External Affairs Ministry today said the first batch of people under the G2G agreement have gone to Israel. Briefing media in New Delhi, Ministry spokesperson Randhir Jaiswal stressed that India is conscious of their safety and has urged the Israeli authorities to ensure their safety and wellbeing. The workers have gone to Israel as part of a Mobility Agreement that India signed with Israel. The agreement predates the ongoing conflict in the region. Replying to a question on China claiming Arunachal Pradesh, the spokesperson said that Arunachal Pradesh is an inalienable part of India and will remain so. On India-Bangladesh ties, Jaiswal said bilateral relations are very strong. He said both nations have a very comprehensive partnership that spans across sectors. On the two Indians who were reported missing after the Taiwan earthquake, Jaiswal said they are now safe and contact has been established with them.

The Health & Family Welfare Department has informed that following the launch of Chief Minister Health Insurance Scheme, CMHIS from 1st November, 2022, fresh approval for Medical Reimbursement, MR Scheme has been discontinued. To address initial issues faced during the implementation of CMHIS, and ensure that CMHIS beneficiaries are not deprived of benefits, the health department has informed that regardless of whether treatment is received at a hospital empanelled under CMHIS or under old MR scheme, if the treatment cost is deducted from the

was undertaken before the deduction of Medical Allowance, reimbursement for the cost of treatment will fall under old MR scheme, regardless of whether treatment was received at a hospital empanelled under CMHIS or old MR scheme. Further, the Department said that cost of treatment will be considered for reimbursement according to approved CMHIS Health benefit Package rate or as recommended by the State Medical Board constituted under the Nagaland Health Protection Society. The department said reimbursement will only be permissible for treatments undergone between 1st November, 2022, and 31st December, 2023 and applicants seeking reimbursement have to submit their application along with all supporting documents as prescribed by NHPS. The notification also clarified that treatment in non-empanelled hospitals will only be allowed in cases of emergencies or when a specific procedure is not available at any of the empanelled hospitals with prior approval from State Medical Board.

A cyber safe east India workshop on cyber security for MSMEs and women entrepreneurs Phase -3 held in Kohima today. Deputy Director of American Center and Assistant Public Affairs Officer, US Consulate General Kolkata Juan Clar said Cyber security is one of the top challenges that countries, companies and individuals face in the twenty first century. Clar said that US and India have become closer strategic partners in many areas and cyber security is one of them. He said it is very important that entrepreneurs of all backgrounds know how to identify and mitigate cyber-security risk. Additional Director, Software Technology Park of India Abhishek Mishra, said cyber security is the lowest priority for Micro, Small & Medium Enterprises, MSME and are vulnerable against cyber threats. He said STPI is working to build MSME networks across the country and provide opportunities to promote them globally. The technical sessions were conducted by resource persons from Centre for Development of Advanced Computing, India.
