Campaigning for the first phase of Lok Sabha elections ended yesterday evening. Voting in this phase will be held in 102 constituencies spread over 17 states and four Union Territories on Friday. All parliamentary constituencies of Arunachal Pradesh, Meghalaya, Mizoram, Nagaland, Sikkim, Andaman and Nicobar Islands, Lakshadweep, Puducherry, Uttarakhand and Tamil Nadu will go to polls in this phase. Voting will also take place for 12 seats of Rajasthan, eight seats of Uttar Pradesh, six seats of Madhya Pradesh, five seats each in Assam and Maharashtra, four seats of Bihar, three seats of West Bengal, two seats in Manipur and one seat each in Chhattisgarh, Tripura and Jammu and Kashmir. One thousand 625 candidates are in the fray for the first phase of Lok Sabha polls. In Nagaland, three candidates are in fray for the state's lone Lok Sabha seat.



The Nationalist Democratic Progressive Party (NDPP) has reiterated its appeal to all the electorates of Nagaland to participate in the exercise of the Universal Adult Franchise on April 19. The NDPP also appealed for peace and tranquility so that voting can take place in a safe and smooth manner in each and every polling station across the State. The NDPP furthered directed all its members not to resort to any means of force. violence, coercion or confront any section of society during the Election Day. Stating that the aspirations of the citizens must always be respected, NDPP maintained that if citizens are unwilling to vote it is their choice and actions to forcefully make them vote should not be undertaken in any manner. The NDPP also congratulated to the first time voters and assured the entire machinery of the Election Commission of India its full fledged support in this ultimate court of democracy. Further, it extended its gratitude to the people of Nagaland for the overwhelming support it received in every nook and corner of the State.



The Nagaland Pradesh Congress Committee (NPCC) has urged every voter within the State to come out of the comfort of their homes and take part in the electoral process by exercising their Constitutional rights on the day of the poll tomorrow. It said, that the right to vote is not just a privilege but a basic human right and a cornerstone of our democracy, allowing citizens to have a say in who governs them and how they are governed. The NPCC also added that it has always upheld the Sovereignty of the Constitution of India and has always encouraged every citizen to uphold the democratic principles and values that emanates from the Constitution. The NPCC further reiterated and appeal to every eligible voter in the State to exercise their Constitutional right on the day of the poll and make a difference by voting for a leader of their choice for a better future.



Eastern Nagaland Peoples' Organization (ENPO) has made a sincere appeal to the 20 legislators from Eastern Nagaland to honor the decision by remaining indoors on the polling day and abstain voting in order to prevent any untoward incidents. In a letter to the 20 Legislators of the Eastern Nagaland, the ENPO expressed a firm belief that the elected members would choose to remain indoors and honoring the decision of the citizens of Eastern Nagaland to abstain from voting for prevention of any untoward incidents. However, they cautioned that there could be public commotion if the elected members decided to go and cast their votes.
