Nagaland today joined the rest of the world in observing World Malaria Day at Nagaland Civil Secretariat. The day was observed with calls for efforts to ensure Malaria Free Nagaland. Principal Director cum Mission Director for National Health Mission, Directorate of Health and Family Welfare Dr. E Motsuthung Patton said the day is observed to reflect on the fight against malaria, a fight that Nagaland has embraced with unwavering commitment and community spirit. Patton said malaria has taken a toll on families, communities, and the economy. Preparations are in full swing for the second phase of Lok Sabha Elections where voting will be held tomorrow. Elections will be held for 88 Lok Sabha seats in 13 States and Union Territories including the remaining part of the Outer Manipur Lok Sabha constituency. Twenty seats of Kerala, 14 seats of Karnataka, 13 seats of Rajasthan, eight seats each of Uttar Pradesh and Maharashtra, six seats of Madhya Pradesh, five seats each in Assam and Bihar, three seats each of West Bengal and Chhattisgarh and one seat each in Manipur, Tripura and Jammu and Kashmir will go to polls in this phase. A total of one thousand 198 candidates from 13 States and Union Territories along with four candidates from the Outer Manipur Lok Sabha constituency are in the fray in this phase.

Election Commission of India (ECI) has taken cognizance of alleged model code of conduct violations by Senior BJP leader Narendra Modi and Congress leader Rahul Gandhi. Kohima District Petroleum Dealers Association (KDPDA) has informed that all petroleum outlets in Kohima will be closed on 26th April. The KDPDA said the closure has been called in support of the Kohima Chamber of Commerce and Industries (KCCI) call for closure of business establishments on April 26 from 6 AM till 6 PM in protest against unabated taxation, intimidations faced by the business establishments. Additional Deputy Commissioner Pfutsero, Moakumzuk Tzudir has ordered the ban on import of pigs to Pfutsero from surrounding villages and other sub-division. The ADC said this has been necessitated as a precautionary measure in the interest of public health as there have been reported death of pigs due to swine flu in villages adjacent to Pfutsero town and other subdivision. The ADC also directed all wards G.Bs to monitor the slaughter and sale of pork in their respective ward and ensure only healthy pigs are slaughtered for public consumption.

Along with the rest of the nation, the 2nd Quarterly National Lok Adalat for 2024 will be observed in all the district headquarters on 11th May. The Lok Adalats will be observed under the aegis of Nagaland State Legal Services Authority, and eleven Lok Adalat Benches will be set-up by the District Legal Services Authority. Lok Adalat an alternative dispute redressal mechanisms, and a forum where disputes and cases pending in the court of law or at pre-litigation stage are settled and compromised amicably. Lok Adalats have been given statutory status under the Legal Services Authorities Act, 1987. Under the said Act, the decision made by the Lok Adalats is deemed to be a verdict of a civil court and is final and binding on all parties and no appeal against such an decision lies before any court of law. There is no court fee payable when a matter is filed in a Lok Adalat. If a matter pending in the court of law is referred to the Lok Adalat and is settled subsequently, the court fee originally paid in the court on the also refunded complaints or petition is back to the parties.
