India and Bangladesh today exchanged agreements and renewed multiple memoranda of understanding (MoUs) across various sectors including digital and green partnerships, maritime cooperation, healthcare, space collaboration, railway connectivity, oceanography, disaster management, and fisheries. The agreements were finalized after talks between Prime Minister Narendra Modi and Bangladeshi Prime Minister Sheikh Hasina in New Delhi's Hyderabad House. Speaking on the occasion, Mr. Modi highlighted Bangladesh's pivotal role in India's Neighbourhood First Policy, Act East Policy, Vision Sagar, and Indo-Pacific Vision, emphasizing their joint completion of significant public welfare projects in the past year.

In a bid to ensure transparent and efficient examination through the National Testing Agency processes (NTA). the Department of Higher Education, Ministry of Education has constituted a High-Level Committee of Experts tasked with making critical recommendations. Chaired by Dr. K. Radhakrishnan, former Chairman of ISRO and Chairman of Board of Governors at IIT Kanpur, the committee includes eminent figures such as Dr. Randeep Guleria, former Director of AIIMS Delhi, and Prof. B J Rao, Vice Chancellor of Central University of Hyderabad. The committee recommendations submit its within two aims to months, emphasizing transparency and efficiency in national examinations.

The Ministry of Personnel, Public Grievances and Pensions has informed that the Centre has enacted a stringent law to curb malpractices in competitive examinations, effective today. The Public Examinations (Prevention of Unfair Means) Act, 2024, includes provisions for a maximum jail term of 10 years and a fine of up to 1 crore rupees for offenders. Passed by Lok Sabha and Rajya Sabha in early February and approved by President Droupadi Murmu on February 12, the law targets cheating in exams conducted by bodies like UPSC, SSC, NTA, Railway Recruitment Board, and banking recruitment agencies. It mandates three to five years of imprisonment for general cheating and five to 10 years for organized cheating, with a minimum fine of 1 crore rupees. The National Testing Agency (NTA) in a public notice has informed that the Joint CSIR-UGC-NET Examination scheduled to be held between the 25th and the 27th of this month has been postponed due to unavoidable circumstances and logistic issues. The NTA said that the revised schedule for the conduct of this examination will be announced later through the official website.

As part of the week-long programme commemorating the International Day Against Drug Abuse and Illicit Trafficking, the Capital Police conducted a significant outdoor session at Chimpu Bn ground today. During the event, participants had the opportunity to share their personal experiences throughout the day. The program also included various activities such as a 100m sprint and tug-of-war among others. A total of 37 participants actively took part in the activities.

An awareness workshop on "eMobility" was organized by the Energy Development Agency Pradesh (APEDA) Arunachal in collaboration with the Namsai District Administration and technical expert iVENCO-Kolkata today. The event which featured an exhibition of electric vehicles was inaugurated by Namsai Deputy Commissioner C R Khampa. Speaking on the occasion, the DC emphasized the importance of transitioning from fossil fuels to vehicles crucial step towards electric as а environmental conservation and reducing air pollution. He praised APEDA's efforts in promoting sustainable energy sources.

The Sub-District Level Monitoring Committee (SDLMC) on Friday convened a crucial meeting at Jang to assess the progress of ongoing projects under Central and State sponsored schemes, and the saturation of Sustainable Development Goals for the first quarter of the year. Speaking on the occasion, ADC cum Chairman SDLMC Jang, Hakraso Kri emphasized the importance of transparency, accountability, and the avoidance of project duplicity among implementing agencies. He also stressed on zero tolerance for malpractices during execution of projects. Meanwhile, ZPC Tawang Leki Gombu stressed on the importance of timely completion of projects to ensure sustainable development of the area without compromising on quality. The 1st quarter District Level Monitoring Committee meeting 2024-2025 for Lower Dibang Valley district was held yesterday under the chairmanship of Dambuk MLA Puinnyo Apum.
