Prime Minister Narendra Modi called for giving priority to the concerns of the Global South, in particular Africa. Addressing the Outreach Session at the G7 Summit in Apulia, Italy on Friday, Modi recalled that it was a matter of honour for India that African Union was admitted as a permanent member of the G20 under its presidency. Modi elaborated on India's energy transition pathway noting that its approach was based on availability, accessibility, affordability and acceptability. Prime Minister Modi congratulated the Group on its 50th anniversary milestone. The Prime Minister also held a series of bilateral meetings on the sidelines of the G7 Summit at Apulia in Italy.



The Supreme Court yesterday sought responses from the Centre and the National Testing Agency on a plea seeking a CBI probe into the allegations of question paper leak and other irregularities in the NEET-UG 2024 examination for admission to undergraduate medical programmes. A vacation bench of justices Vikram Nath and Sandeep Mehta, which was hearing a PIL, also sought responses from the Central Bureau of Investigation and the Bihar government within two weeks. It said, the PIL will also be taken up with other pending ones on the 8th of July.



The mortal remains of 45 Indian nationals who lost their lives in the fire incident in Kuwait were brought back to India by a special Indian Airforce flight. Out of a hundred and 76 Indian workers who were present in the housing facility at the time of the fire, 45 died and 33 were hospitalized with injuries, while the remaining are safe. As per the External Affairs Ministry, it continuously coordinated with the authorities in Kuwait to provide assistance to the injured and to ensure the safe return of all affected individuals.



The Self-Defense Training for 214 Government school Master trainers concluded yesterday at Pele Khezhie's Taekwondo Stadium, D Khel Kohima. This policy applies to all HEIs under Central or State Acts, UGC-recognized institutions, deemed universities, and organizations involved in admissions counselling.
