Prime Minister Narendra Modi reached Moscow this evening on a three day official visit to Russia and Austria. He received a Guard of Honour at Moscow airport. Modi taking to social media platform X said that he look forward to further deepening the Special and Privileged Strategic Partnership between the two nations, especially in futuristic areas of cooperation. He said stronger ties between our nations will greatly benefit our people. During the 22nd Annual Summit between India and Russia tomorrow, Prime Minister Modi and Russian President Vladimir Putin will review the whole range of bilateral issues. They will also share perspectives on

regional and global developments of mutual interest. Both leaders will also assess the status of bilateral engagements in BRICS, Shanghai groupings as Cooperation such Organization, G20, East Asia Summit, and the UN. Tomorrow, Prime Minister will interact with the Indian community in Russia. He will also lay a wreath at the Tomb Of The Unknown Soldier in Kremlin and visit the Rosatom the exhibition venue in Moscow. engagements will be followed by restricted level talks between the two leaders, which will then be followed by delegation level talks.



The Supreme Court has asked the Centre and National Testing Agency (NTA) to file a report before it on the NEET UG paper leak case. The top court also directed the CBI to file a status report on its investigation into the case so far. The apex court has asked the NTA. Centre and the CBI to submit their reports before it by 5 PM on Wednesday. A bench comprising Chief Justice DY Chandrachud, Justice J B Pardiwala and Justice Manoj Misra was hearing a batch of pleas related to the NEET-UG exam, including those alleging irregularities and malpractices in the medical test and seeking a direction to conduct it afresh. The Chief Justice of India said the fact that sanctity of the exam is compromised is beyond question. He said, however, before ordering a retest, the extent of the leak needs to be known. The top court stated that cancellation of exam is the extreme last resort. The matter is now listed for hearing on Thursday. NTA conducts the National Eligibility cum Entrance Test (Undergraduate) or NEET-UG admissions to MBBS, BDS, AYUSH and other related courses in government and private institutions across the country.

National Testing Agency has released the answer key for the Common University Entrance Test-Undergraduate (CUET-UG 2024). The window for students to challenge the answer keys is open till tomorrow. Release of answer keys sets the stage for the announcement of results. The results are expected to be announced within a week. The answer key provides candidates with an approximate idea of their scores and chances of admission to the 261 participating universities. For the first time, CUET-UG was conducted in a hybrid mode. For 15 subjects, the tests were pen-paper based, while the other 48 subjects were computer-based. This year, over 13.4 lakh candidates registered for the common entrance test for admission to undergraduate courses in 261 central, state, deemed, and private universities.



In view of the continuous inflow and rising water levels at Doyang, the Deputy Commissioner of Wokha informed that the radial gates of the Doyang Dam are likely to be opened to release the excess water in a controlled manner. As such, the Deputy Commissioner in a public advisory said, the during the exercise, the excess inflow will spill over and flow through the Doyang river downstream of Doyang power house. Therefore, the public have been advised to stay away from the downstream of Doyang River by avoiding swimming, fishing, camping at riverside or any other activities during the period when the radial gates is open.



The Supreme Court directed the Centre to frame a model policy on menstrual leave for women employees by holding consultations with states and other stakeholders. A bench comprising Chief Justice D.Y. Chandrachud, Justice J B Pardiwala and Justice Manoj Misra, today, disposed of the PIL seeking menstrual leave policy and directed the Ministry of Women and Child Development to hold stakeholder meetings to consider framing a policy on the same. The bench said it is a policy-related issue and not an issue for the courts to look into. Moreover, a decision from the court on granting such leave to women may prove to be counterproductive and detrimental as employers may avoid employing them. The top court further said that this direction will not stand in the way of the state government making independent decisions on the policy for menstrual leave.



Neikhozo Suokhrie was elected as Chairperson of Kohima Municipal Council (KMC) while Khrielievi Chusi has been elected as Deputy Chairperson. The decision was made during a meeting of the High Power Committee for the formation of ULBs in KMC, held at NDPP Central Office in Kohima. The committee comprises of Salhoutuonuo Kruse, the Legislator-in-charge and Minister for Women Resources Development and Horticulture; Dr. Kekhrielhoulie Yhome, Advisor for School Education and SCERT; Theyiekielie Tachu, Vice-President CEB, NDPP; and Prasielie Pienyu, President of NDPP Kohima Region, along with the elected Councilors of KMC from NDPP. The NDPP holds 13 out of the 19 wards in Kohima.
