Nagaland Governor La Ganesan has revoked the order summoning the fifth session of the 14th Nagaland Legislative Assembly on August 6, 2024. Assembly Secretary-in-Charge, Khruokituonuo Rio in a press release today said that the Governor through an order has revoked the earlier order issued which was issued on June 3, 2024.



The Government at the Centre has convened an all-party meeting on Sunday ahead of the Budget Session of Parliament. During the meeting, the government will seek cooperation from all political parties to ensure the smooth functioning of both Houses of Parliament. The Budget Session will be held from 22nd of this month to 12th of next month. The Union Budget will be presented on 23rd of July. It will be the first Budget of the Narendra Modi Government in its third term.



Naga Students' Federation, NSF has commended Nagaland Government for filing a writ petition in the Supreme Court of India challenging the decision of the Central Government with regard to the Oting massacre of December 2021. The state government through the petition challenged the central Government's denial of sanction to prosecute the Indian Army personnel involved in the incident which claimed 13 innocent lives. NSF President Medovi Rhi and Assistant General Secretary Kenilo Kent in a press release today said that the bold step taken by Nagaland government underscores the state's commitment to justice and accountability in the face of grave human rights violations. The Federation said the Supreme Court's decision to issue a notice to the Union Ministries of Defence and Home Affairs is a significant development. NSF said, it stands in solidarity

with the State Government's petition, emphasizing the necessity of judicial review in cases where there is a refusal of prosecution sanction, as upheld in the landmark Naga People's Movement for Human Rights versus Union of India. Further, the NSF reiterated its call for the repeal of the Armed Forces (Special Powers) Act from the Naga homeland.



The Konyak Union, KU lauded Nagaland government for its decisive action in prosecuting 30 para commandos' personnel of the 21 Para, Alpha Team, who were involved in the tragic massacre of 14 innocent civilians at Oting village on December 4, 2021. KU in a press release said the state's government move to take the matter at the Supreme Court is a significant step towards ensuring justice for the victims of this horrific incident. It said the KU previously met with Home Minister Y Patton to appraise the matter and advocate for the case to be perused at the highest judicial level. The Union expressed optimism that justice will soon be delivered to the victims and that those found guilty, regardless of their uniform, will receive appropriate punishment. Further, KU said that it hopeful that the state government will continue its relentless efforts to bring justice.



Coordination meeting of Chiephobozou Sub-Division between Government Departments and Chiephobozou Town Council was held yesterday at DB's Court Chiephobozou. The meeting was held to discuss the overall development of the town and to work as a team in building a model township. Chairing the Meeting, Chiephobozou ADC, Alemyapang Longchar called upon all the new councilors, Head of Departments and town leaders to render their best service with full dedication towards development of the town. Sechü said the most proud aspect of Naga heritage for her is the Hornbill Festival of Nagaland, which would be highlighted through participation in Miss Grand India.

Ministry of Education has extended the last date for accepting Self-nomination for National Teachers' Award 2024 till 18th July 2024. The Ministry said that applicants who have partially filled up their self-nomination as on 18th July 2024, may submit their final submission of self-nomination by 21st July. In this regard, all District Education Officers, Senior Sub Divisional Education Officers and SDEOs have been requested to disseminate the information to the teachers under their jurisdiction.
